INTRODUCTION:

The following Tree Inventory and Arborist Report has been prepared for Landscape Planning Limited. Site location is 5688 Main St, Whitchurch-Stouffville, ON L4A 7Z9.

All trees 15cm in diameter and greater, measured at 1.37m from grade (DBH) within the property and beyond 6m have been inventoried. Information gathered was as follows:

1. Tag number
2. Species
3. Diameter (DBH)
4. Health and structural condition rating
5. Reason for poor rating

Health Rating Table

Very Poor < 20%	Tree displays severe dieback of branches, canopy is extremely sparse. May exhibit extreme pathogen infestation or infection. Or tree is dead.
Poor >20% - <40%	Tree displays some dieback. Branches or canopy is sparse with little or no signs of new growth or vigor. Possible pathogen infestation or infection. Foliar canopy is sparse.
Average >40% - <60%	Tree is developing in a manner typical to others in the area. Canopy is full.
Good >60% - <80%	New growth is vigorous as evidenced by stem elongation and color. Canopy is dense.
Very Good >80% - 100%	In addition to the attributes of a good rating, tree is displaying extremely vigorous growth and trunk displays a pattern of vigor cracks or lines.

Structural Rating Table

Very Poor < 20%	Trunk has large pockets of decay, is bifurcated or has a severe lean. Limbs or branches are poorly attached or dead. Possible hazard.
Poor >20% - <40%	Limbs or branches are poorly attached or developed. Canopy is not symmetrical. Trunk has a lean.
Average >40% - <60%	Trunk, limb, and branch development though flawed is typical of this species.
Good >60% - <80%	Trunk is well developed with well attached limbs and branches; some flaws but are hardly visible.
Very Good >80% - 100%	In addition to attributes of a good rating, the tree exhibits a well developed root flare and a balanced canopy.

1. Preserve, Protect & Maintain

Includes protection with tree preservation hoarding, as well as pre- and post-construction arboricultural works.

2. Preserve & Protect

Includes the installation of tree protection hoarding; no maintenance will be required unless otherwise stated.

3. Retain

No protection or maintenance measures are required. Installation of tree protection barriers is optional.

A total of 37 trees have been tagged and inventoried.

The Urban Arborist Inc attended the subject site on April 5, 2024 to conduct a tree inventory and arborist report of all trees on the subject lot as well as any trees abutting the property within 6m measuring 20cm in diameter (DBH) and greater.

A total of 37 trees were tagged and inventoried. There are 33 trees to be removed. A total of 4 trees are to be preserved and protected. See Tree Inventory Table attached and Tree Protection Plan Drawing TP-1 by Landscape Planning Limited.

The total amount of replacement trees required is to be determined by the Town of Whitchurch-Stouffville.
