Acknowledgement: Any election signs erected or installed in violation of York Region By-law 2025-62 or the Town of Stouffville By-law 2018-050-RE shall be removed under the direction of the Manager of Municipal Law Enforcement. Election Signs removed for non-compliance with the Town of Stouffville Election Sign By-law cannot be retrieved. In addition, for each sign the Town removes for non-compliance, \$10 will be deducted from the \$250 deposit paid at the time the permit was issued. Any remaining balance of the deposit will be returned following the election. Any other fees are per the Town's Fees and Charges By-law 2025-079-FI.

Unpaid invoices may be collected by action or the amount added to the tax roll and collected in the same manner as taxes.
