

Town of Whitchurch-Stouffville Committee of Adjustment Schedule - 2025

1. Pre-Consultation Application for Consent Applications

As per the provisions of the Planning Act, Town Staff strongly suggest that Applicants complete the Pre-Consultation process prior to making a consent application. The pre-consultation meeting allows the applicant and/or their representative to discuss the development proposal with Town staff and relevant external agencies and to identify the information and materials required for submitting a Complete Application for Consent, as required by the *Planning Act*.

2. Mandatory Preliminary Zoning Review (PZR) for Committee of Adjustment Applications

A Preliminary Zoning Review Notice (PZR) is <u>mandatory</u> for submitting a complete Committee of Adjustment Application. Please contact the Zoning Administrator in the Town's Building Department to request for a PZR <u>prior to the Material Deadline as noted in the table below, the PZR process may take up to ten (10) <u>business days to complete</u>. The PZR Application Form can be found on the Town's Website at <u>www.townofws.ca</u>. Planning Staff will take no responsibilities for any delays in obtaining the PZR from the Building Department. Committee of Adjustment Applications without a PZR Notice received for Planning Review, will not be accepted by the Planning Department.</u>

3. Material Submission Deadline

Applications must be complete and received no later than 12:00 Noon on the Material Submission Deadline date. Applications not meeting this deadline will automatically be placed on the Agenda of the next Committee of Adjustment scheduled hearing/meeting.
